Terms and conditions for H&HHVC “Life in Lockdown in TW12” Photography Competition 2020

This Photography competition (the ‘Competition’) is subject to the following Terms and Conditions (‘Conditions’) and by entering the Competition you agree to be bound by them.

1. By entering the competition, you warrant Hampton & Hampton Hill Voluntary Care (H&HHVC) that all information submitted by you regarding yourself and your competition entry (‘Entry’) is true and accurate and complete in every respect. H&HHVC reserves the right to verify any information provided in connection with your Entry.
2. All Entries must be received by 5.00pm (BST) on 4 June 2020 (‘Closing Date’).
3. The Competition is open to persons who are resident in TW12 postcode locality (UK) only.
4. H&HHVC shall be entitled to assume that the parents or guardians of any entrant who is less than 18 years old have consented to that person’s entry into the Competition. Entrants may be required to provide proof of identity and if aged under 18, should be able to demonstrate to H&HHVC satisfaction that their parent or guardian has given their consent to such entry.
5. H&HHVC reserves the right in its absolute discretion to disqualify any entrant if it believes that an entrant has breached any of the Conditions, any applicable law (including without limitation copyright law) or has infringed the intellectual property of any other person. Each entrant acknowledges and agrees that any failure to comply with the Conditions may lead to H&HHVC disqualifying that person, without H&HHVC being required to give any reason for such disqualification or granting any opportunity for challenge.
6. Employees of H&HHVC, their relatives or any agents or employees are not eligible to enter the Competition, but may submit a photograph to add to the H&HHVC portfolio.
7. **Competition entries**
 - a. Entries should be submitted in the best resolution format available, we recommend a minimum 350 dpi. Entries should be submitted by the Closing Date (4 June 2020) and in the manner set out in these conditions. Failure to do so may result in disqualification.
 - b. H&HHVC will not accept photographs submitted in hard copy.
 - c. Entries will only be accepted via “We Transfer” and sent to enquiries@greenwoodcommunity.org.uk. Any file sent direct to this address, or to any other address will be immediately deleted.
 - d. An individual may only enter 1 photograph. Any subsequent entries will be disqualified.
8. **Prize-winner**
 - a. The prize-winner will be selected and notified by 1 August 2020 at the latest, by email. A selection photographs will be displayed on www.greenwoodcommunity.org.uk. The overall winner will receive a small hamper with a selection of food items etc.
9. **Liability**
 - a. H&HHVC accepts no responsibility for Entries lost, damaged or delayed whether due to transmission errors, website malfunction, computer error or otherwise.
10. **Intellectual property rights and data protection**
 - a. Entrants agree to their pictures appearing on the H&HHVC “Greenwood Community Centre” web site (www.greenwoodcommunity.org.uk), as well as on Facebook, twitter and other social media. The choice of images is at the sole discretion of H&HHVC.
 - b. By submitting an Entry in the Competition you grant to H&HHVC a non-exclusive royalty-free worldwide commercial licence unlimited in time, to use the Entry (whether or not it wins the Competition) in all formats and in any medium of communication, and for all promotional purposes which H&HHVC shall consider appropriate. You represent and warrant to H&HHVC, with the intention that H&HHVC shall rely on such representation and warranty, that each of your Entries is original, and that you own each of them exclusively and have the right, without the permission of any other person or legal entity, to license to H&HHVC the rights in the Entry for all the purposes contemplated in these Conditions. The scope of the licence granted to H&HHVC in this paragraph 10 shall include your irrevocable permission to H&HHVC to use, reproduce, publish, display, transmit, copy, amend and store.
 - c. H&HHVC will not sell your image or use it with the express purpose to make profit.
 - d. Any personal information relating to entrants will be used by H&HHVC in accordance with data protection legislation in force in England.
 - e. All Competition entrants unconditionally agree to the use of their name in connection with any Entry which is published in any form in any media.
11. **Governing law and jurisdiction**
 - a. These Conditions and any dispute or claim arising out of or in connection with them or their subject matter (including the Competition), validity, termination or enforceability (including non-contractual disputes or claims) shall be governed by and construed in accordance with English law.
